Please Read the Following Information Before Proceeding:

What Is the Executive Office for Immigration Review (EOIR) Pay.gov Website?

The EOIR Pay.gov website gives you the option to pay "online" for some fees related to filing immigration case appeals and motions. The Pay.gov process is simple. Using a computer with a printer, you pay your filing fee electronically by providing a credit card or bank account number. Then you print a computer-generated receipt---called the "Payment Confirmation"--and attach it to your appeal or motion.

Most important, your "Payment Confirmation" is your proof of payment, so you MUST print it and you MUST attach it to the appeal or motion that you are filing. A separate "Payment Confirmation" is required for **each** appeal or motion that you pay for online.

Who Can Use Pay.gov?

Any individual or organization can use this service.

What Can I Pay for Using Pay.gov?

- An appeal to the Board of Immigration Appeals of an Immigration Judge's decision (Form EOIR-26),
- A Motion to Reopen with the Board of Immigration Appeals, and
- A Motion to Reconsider with the Board of Immigration Appeals

What Do I Need In Order To Use Pay.gov?

You must:

- Have the name and alien number (the eight-digit number that begins with the letter "A") of the respondent (the person who is in immigration proceedings),
- Know what type of appeal or motion that the respondent is filing,
- Have a credit card or bank account, and
- Have access to a computer with a printer, so that you can print a computer screen.

How Do I Pay Using Pay.gov?

- First, follow the instructions and provide the requested information, including the credit card number or bank account number that you will use for payment.
- Second, you should write down your "Agency Tracking ID" number on a separate piece of paper for your records before you print your "Payment Confirmation" - in case you forget/fail to print the "Payment Confirmation" or lose it and you don't have e-mail confirmation of your payment. Remember, a printed copy of your "Payment Confirmation" is your proof of payment.
- Third, print the "Payment Confirmation," which is your proof of payment.
- Fourth, attach that "Payment Confirmation" to your appeal or motion application.

How Do I Begin the Pay.gov Payment Process?

If you wish to pay for an appeal or motion using Pay.gov, you may continue to the next page.

NOTE: It may take several minutes to process the payment form. Please be patient.

Important Information -- Please Read Carefully:

- You **MUST** complete all questions marked with an asterisk *.
- As you complete your payment, Pay.gov will assign an "Agency Tracking ID" number -- a unique number that identifies your payment. You may want to write down your "Agency Tracking ID" number on a separate piece of paper for your records.
 - **NOTE:** If you forget/fail to print the "Payment Confirmation" or lose your "Payment Confirmation" and you do not have e-mail confirmation of your payment, then the only way that you will be able to confirm your online payment is by providing the Board of Immigration Appeals your "Agency Tracking ID" number.
- After you pay your fee, you **MUST** print the "Payment Confirmation" and you **MUST** attach it to the appeal or motion application that you are filing. Your "Payment Confirmation" is your proof of payment, so you must attach a separate "Payment Confirmation" for **each** appeal or motion that you pay for online.
- For Family Cases:
 - If the Immigration Judge's decision covers the respondent's entire family, you **MUST** file only appeal or motion and pay only **one** \$110 filing fee for the appeal or motion.
 - If the Immigration Judge issued a separate decision for anyone in the family, you **MUST** file a **separate** appeal or motion and pay a **separate** \$110 filing fee **for each family member who has a separate decision.**
